    - 6. Essay.
    - 7. Any disciplinary actions of the active Explorer or member.
    - 8. Full time/part time student.
    - 9. Only one scholarship payout per person.
- IV. Maximum annual payout is \$2,000.00.
- V. Decisions made by the Scholarship Committee are final.

### 1. Introduction.

The Atco Volunteer Fire Company is proud to present the Carl Hasselhan Memorial Fund Scholarship to the members of the Waterford Township Fire Department and the relatives of members that work in public safety in Waterford Township.

This scholarship was created to honor the memory of Firefighter Carl Hasselhan. Carl was an Atco Volunteer Firefighter who lost his life in the line of duty in 1979. It will be awarded to someone who serves, or has family that serves, in a branch of public safety in Waterford Township.

The required essay needs to be attached to this application along with your most recent report card with GPA, and a copy of your enrollment letter. <u>Applicants must mail their submissions to the Atco Volunteer Fire Co. and be postmarked no later than April 30th</u> for the fall semester of that same year.
- d. You must follow all directions. Failure to do so will invalidate your request.
